#### **SECTION 4: First aid measures**

##### **4.1. Description of first aid measures**

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

### 5.3. Advice for firefighters

## SECTION 7: Handling and storage

### 7.1. Precautions for safe handling

**Usage precautions** Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Handle all packages and containers carefully to minimise spills. Keep container tightly sealed when not in use. Avoid the formation of mists. ### 7.2. Conditions for safe storage, including any incompatibilities

### Appropriate engineering controls

Provide adequate ventilation. Good general ventilation should be adequate to control worker exposure to airborne contaminants. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimise worker exposure.
