### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. ## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

**Suitable extinguishing media** Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

### 5.2. Special hazards arising from the substance or mixture

**Specific hazards** FLAMMABLE. Solvent vapours may form explosive mixtures with air. Containers can burst violently or explode when heated, due to excessive pressure build-up.

### 5.3. Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak.

### SECTION 7: Handling and storage

#### 7.1. Precautions for safe handling

**Usage precautions** Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Handle all packages and containers carefully to minimise spills. Keep container tightly sealed when not in use. Avoid the formation of mists. Do not handle until all safety precautions have been read and understood. Do not handle broken packages without protective equipment.

#### 7.2. Conditions for safe storage, including any incompatibilities

### Appropriate engineering controls

Provide adequate ventilation. Good general ventilation should be adequate to control worker exposure to airborne contaminants.
